KAVANAUGH: David, the thing is if, if I 22 play -- if I get them to play this scripture, I mean 23 it's like I want you to, you know, do something from my 24 side, I mean --25 MR. KORESH:

I am.

I, I gave you the

scripture so you could know what you're fighting 2 against. 3 MR. KAVANAUGH: Well, I understand that, but I mean, I'm going to get it played on the radio and I'd 4 like to see some people that are hurt come out. 5 6 MR. KORESH: What the --7 MR. KAVANAUGH: One person, one person, that's all, just one person. If you'll agree to send 8 9 one --10 MR. KORESH: Well, you've already got, you've already got some people down at the, the shop. You've 11 12 already got --MR. KAVANAUGH: I don't know. I haven't been 13 14 at the shop. 15 MR. KORESH: Yeah, you know, you already got those guys, they're with you. 16 17 MR. KAVANAUGH: If you send out --MR. KORESH: You already got Paul Fatta and 18 (indiscernible). 19 20 MR. KAVANAUGH: Okay. I, I wasn't aware of 21 that. 22 MR. KORESH: You know? 23 MR. KAVANAUGH: Yeah, but I mean if you'd send out any mother and child, one or two. I'm not 24 asking you to send out all your people, I'd just like 25 to get somebody maybe that's hurt or scared out, I'll,

I'll get this played and then we'll go to Step 2. 1 2 let's do it. 3 MR. KORESH: All right. Let me go run and ask again and see if anybody wants to leave, you know. 4 5 MR. KAVANAUGH: They're going around and asking again if anybody wants to leave. 6 7 MR. KORESH: So you want to call me back? 8 MR. KAVANAUGH: No, let's not hang up. Let's not hang up. I'll tell you what, if you want to rest 9 why don't you just lay the phone down and, and leave an 10 open line because what happens is all these neighbors 11 and stuff get on these phones and I couldn't get you, 12 you know? And you and me have to work it out. I mean, 13 and everything, and everything is okay if you and me 14 are talking and, and that's the main thing. Because 15 you care for people and, and you're sincere and honest. 16 17 MR. KORESH: I care about my Father [gap] 18 MR. KAVANAUGH: That's right. 19 MR. KORESH: -- in Heaven. 20 MR. KAVANAUGH: I know you do. 21 MR. KORESH: I care about --22 MR. KAVANAUGH: I don't know why they call you a cult when you're just religious people. I can't believe that the radio says that stuff, but you know we 24 don't tell them that. Do you understand, David? 25 MR. KORESH: But that's what they say and

that's why you can't blame them. MR. KAVANAUGH: Well, people call you that, I 2 don't, I don't -- we don't fee! that way. I mean, we, 3 4 we know you just --MR. KORESH: Come on, come on, look --MR. you know, God also has an army. You need to read 2 Isaiah 13, see what can happen on you. It's nonsense to have so many -- there's no heros in this kind of 3 4 stuff, man. 5 MR. KAVANAUGH: What's that? Hold on, David. What's that? A radio guy? You tell him that I --6 that -- you tell them Jim Kavanaugh said he -- we might 7 have a message for him to play and I -- and he's going 8 to have to do it. All right. Hang on a minute. 9 MR. KORESH: All right. 10 11 MR. KAVANAUGH: Yeah, get that message back to him, you tell him that I -- yeah, that's right, 12 okay. All right. Hold on. All right. Look ---13 14 MR. KORESH: You can tell them I've been wounded and shot if you want to, that might make them 15 16 happier. 17 MR. KAVANAUGH: Well -- no, well, I don't 18 know -- you know, I can't -- you know how the news media is? I mean, they're -- they do things on their 19 own but we're, we're trying to do everything we can to 20 do what's right by you. And let's do this: let's make 21 an agreement. I'm going to get this thing on the air, 22 the word about the seven seals will be out. We'll have 23 an, an agreement, a couple of people, once the word 24 comes back if anybody wants to go and then the message 25 will be out, then we'll talk further. I, I, I like

dealing with you because you're the guy in charge and, and, and those people believe in you like no others in 2 the world and they --3 4 MR. KORESH: Yeah. 5 MR. KAVANAUGH: -- will do what you tell them 6 to do, what you ask them to do. 7 MR. KAVANAUGH: But I can only do what my Father has written for me to do, that's why those 8 people are supposed to know that I'm not crazy. If I 9 10 did not --11 MR. KAVANAUGH: I don't think you're crazy. MR. KORESH: -- look, look, if I did not show 12 people from the book the word of God what God has 13 stated shall be in the last days --14 15 MR. KAVANAUGH: Um-hum. 16 MR. KORESH: -- about my coming and why I 17 come this way --18 MR. KAVANAUGH: Um-hum. 19 MR. KORESH: -- that I will not allow anybody to believe me. You cannot be flesh and blood. 20 what is written in the testimony from those who started 21 the Christian Church, you know, Moses [gap] Malachi --22 MR. KAVANAUGH: Let me ask you something, let 23 me ask you something, you may know about this. What 24 about that thing they call the, the Ark? Do you know 25 about that? I --
